Entry & Payment Info: All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. All fees include CFA surcharge. Please check confirmations for accuracy and confirm online entries with the entry clerk; neither the club nor the entry clerk will be responsible for non-confirmed entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. Make checks payable to Cincinnati Cat Club. Returned check fee is \$50 plus any bank fees. Credit card payments accepted by PK, for the Club.

Show Hall: Butler County Agricultural Society, 1715 Fairgrove Ave., Hamilton, OH 45011, 513/892-1423. The show hall is handicap accessible, heated & air-conditioned. A food vendor will be on-site. Hotel info. will be sent with confirmation.

Benching & Show Hours: Check-in is between 8:00 to 8:45 am. Report any transfers or absentees at check-in. Cats not checked-in by 8:45 am will be marked absent. Judging will begin at 9:00 am. Advertised show hours are 9:00 am to 5:00 pm Saturday. Single cage size: 22" x 22" x 22" and is included with your entry. Please bring cage curtains, fabric or towels for the top, sides and bottom of your benching cage, grooming aids, your own food/water bowls and litter pan. Litter will be provided. Novice Exhibitors let us know if you are new to showing; we are happy to help you learn about CFA and showing.

Awards: This is a CFA licensed show and all show rules will be strictly enforced. Copies of the show rules are available online as a (pdf) from www.cfa.org or from CFA, 260 East Main St., Alliance, OH 44601 for \$7. Rosettes and ribbons will be awarded in accordance with CFA Show Rules. Permanent ribbons will be used for color classes.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition.
