Entry & Payment Info: Entries are accepted now.. Please confirm online entries with the entry clerk; neither the club nor the entry clerk will be responsible for non-confirmed entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Payment options will be sent with your confirm. No substitutions after closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy; contact the entry clerk with any corrections BEFORE CLOSING DATE..

Show Hall: Exhibit Hall @ Suburban Collection Showplace 46100 Grand River Ave. Novi, MI 48374 Ph: (248)348-5600. The show hall is heated and air-conditioned as needed and is handicap accessible. This is a non-smoking facility. **No outside food allowed.** Food and drinks (sandwiches, hamburgers, snacks, drinks, etc.) will be available at a concession stand. Parking is \$5/day.

Show Hours: Check-in 7:30-8:30am; judging will start at 9 am both days. Show hours are 9 am – 5 pm (or end of finals) Saturday and Sunday.

Benching: Single cage size is approximate 22" x 22" x 22"; and is included with your entry. **Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage.** Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Show Rules: CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

Local Airports: Detroit Metropolitan Wayne County Airport (DTW) is about 30 miles/45 minutes from the show hall.
