No payments at the door.** Fees must accompany all entries or be **received within 10 days if faxed or online.** All entries in Championship (except Novice), Premiership (except Novice), *registered* Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. This is a CFA licensed show and all CFA Show Rules will be enforced. For a copy, contact CFA, 260 East Main Street, Alliance, OH 44601. No kittens under the age of 4 months will be allowed in the show hall. **ONE BENCHING REQUEST PER EXHIBITOR WILL BE HONORED, IF POSSIBLE, AND MUST BE MADE AT TIME OF ENTRY.** **Hotel:** Quality Inn and Suites Medina, 2850 Medina Rd, Medina, OH 44256, 330-723-4994. Small block of rooms for this show will be held until August 5th at a reduced rate. Pet fee waived (please be responsible). Hotel includes Hot Continental Breakfast, Indoor pool. Just ask for rooms for SCBF.

Benching will be from 7:30 to 8:30 am on Saturday with judging to start at 9:00 am. All cats must be checked in. No veterinary inspection required prior to benching. Cats should be inoculated against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), rhinotracheitis, calici and rabies. It is strongly recommended that all be tested and found negative for FeLV. **All** claws must be clipped prior to benching. **Advertised show hours are 9:00 am - 5:00 pm on Saturday and 9:00 am - 4:00 pm on Sunday.** No watchman will be on duty Saturday night. The Club will take all reasonable care of personal property but will not be liable for loss or damage. Show hall is handicap accessible. Handicap benching (end of row) is available upon request at no extra charge. No refunds for failure to bench. Litter will be provided, bring your own boxes. People food will be available. Hall is air-conditioned. No alcoholic beverages are permitted. Rosettes will be awarded per CFA rules. Permanent flats will be used - cloth ribbons available. Cage size is 22" x 22" x 22" (single). Map and motel information sent with confirmation. Exhibitors are responsible for their own transportation. Flying in - use Cleveland Hopkins Airport.
